Dear Bishop,

When troubled teens don't respond to their parents, church leaders or therapists, some parents see residential treatment as the only solution.

However, there is an effective alternative...

UtahYouthVillage has been providing a treatment approach for families with troubled children and youth since 1994 and has worked with thousands of families. This approach is generally more effective and efficient than residential treatment, even with youth that seem to have very serious issues.

It is called Families First.

Referrals come from schools, bishops, therapists, juvenile courts, state agencies, insurance companies and community organizations.

98% of the families served recommend this program to other families with seriously troubled children.



Utah Youth Village

For the last 40 years Utah Youth Village has been one of the most successful providers of residential treatment in Utah. Currently we are one of the largest providers serving the very difficult youth who are wards of the state or are in Juvenile Corrections.

We know the strengths and weaknesses of residential treatment.

Our experience has taught us that in most cases the Families First program can create the same level of change in troubled youth as residential treatment except that Families First has the following advantages:

- 1. Parents are much more satisfied with the results in the long run.
- 2. Parents feel much more support.
- 3. Parents feel that they regain control of the family.
- 4. It costs a fraction of the cost of residential treatment.
- 5. The relationship between the parents and the child is not damaged by the personal rejection a child feels when he/she is removed from the family and placed in residential treatment.
- 6. The effects of Families First helps all of the children in the family, not just the referral child.
- 7. The intervention is only six weeks, taking much less time.
- 8. The change created in the youth is more enduring.
- 9. The Families First specialist is available for crisis help to the family for up to a year after the service.



What is Families First?

Families First is an intensive in-home intervention designed to give families the tools they need to solve their problems. It builds on the family's strengths and empowers parents with proven strategies to change the behaviors of their troubled child(ren).

Teens and parents learn and practice new skills in their home "in the moment" and with real life situations.

A highly-trained Families First Specialist spends up to 10 hours a week with the family, in their own home, for six weeks. The Specialist is an ally of the parent(s), strengthening and supporting them. Parents are never criticized. Research based strategies change the behaviors of the troubled youth. After the intervention, the Specialist remains available to the family by phone for up to a year.

Keeping the Bishop involved.

Bishops are given weekly progress reports by the Families First Specialist. The summaries can be delivered either electronically or through the mail.



Teaching-Family Model

Families First is based on the parenting technology of the evidence-based Teaching-Family Model, one of the most researched treatment approaches for troubled youth in use today. It is based on the inherent power of the parent to change a child's behavior. For a more complete description, go to www.teaching-family.org.

Although Utah Youth Village has been the recipient of volunteer support from the LDS Church, it is a nonsectarian organization with no affiliation or connection with the LDS Church.

Families First specialists may or may not be active members of the LDS Church. Because of the soundness of the principles taught, families who have been referred by Bishops have been pleased with their assigned specialists without regard to the specialist's religious affiliation. We have never had a complaint in this regard.

When Families First is Not Effective

Families First is not appropriate if the youth presents with active suicide risk requiring hospitalization or detoxification for substance dependence or abuse. However, once the youth is stabilized, Families First can be very effective dealing with the issues leading to suicidal ideation and substance abuse.

Tailored to Family Needs:

The Families First Specialist will schedule his/her time with the family around the family's schedule, including home visits on week nights and weekends.

The Families First Specialist is available for crisis intervention or consultation 24 hours a day, 7 days a week.


Evidence-based:

Families First has been extensively and rigorously studied. These studies include:

A three-year, controlled experiment which found statistically significant improvement in child behavior and decreased recidivism resulting in improved family stability.

A five-year pre-post survey across 951 families which documented an average 24 point improvement in youth behavior over the course of the Families First intervention – double the number needed for statistically reliable change.

Areas of Specific Change: Based on YO-Q scores at the completion of a Families First intervention, youth improvements were observed in the following six areas:



Effective Over Time:

Both studies mentioned above provide evidence of enduring, sustained improvement including:

Recidivism in the Juvenile Justice System was reduced by half.

In the study comparing a treatment group with a control group, there was no recidivism (on average) in the negative behaviors of the treatment family's troubled youth six months after the Families First services. The changes last.

Reports of Consumer Satisfaction:

In satisfaction surveys over the last three years...

- 99% of **parents** report that the Families First intervention had been effective at reaching the family's goals.
- 95% of youth report that the Families First intervention had been effective at reaching their goals.
- 97% of **associated agencies** and other **professionals** also report that the Families First intervention had been effective at reaching their goals.

Pricing Options

Families First is available to you as a Bishop at: (1) Full Price, (2) Half Price or (3) Free if the service is needed along the Wasatch Front, in Tooele County, from Logan to Payson/Santaquin and from Heber City to Grantsville.

Families First is available only at full price in Monticello, Blanding, Cedar City and St. George.

Full Price: The full price for Utah Youth Village to provide the Families First service is around \$4,500. This puts the family to the top of the list to be assigned the next available Families First Specialist. This is typically 0-2 weeks.

Half Price: If the family can wait until the families paying full price are served, the cost will be \$2,250 or half price. This can be 2-6 weeks.

Scholarships: A family can receive the service for free if they can wait until the full price and half price paying families are served. Call Sheila at 272-9980 for an estimated wait time. This can be up to 6 months or more. (Scholarships are available to families through the generosity of UtahYouthVillage donors. Scholarship funds are limited and are available to any referred family, not just those referred through LDS Bishops.)

The parents have found a residential treatment program they want

In a study done by a local insurance company, twenty children of insured families were mandatorily referred to Families First before the insurance company would cover residential treatment for them.

All families had requested residential treatment. Before this study, all would have been referred to residential treatment or hospitalization.

After Families First, only one of the twenty youth was hospitalized, and it was only for several weeks. None went into residential treatment. The parents experienced a higher level of satisfaction with the service because they felt they had control of the troubled youth and the family when the intervention was done. This is not always the case when referring youth to residential treatment.

In this study, some of the parents who were forced to do Families First instead of residential treatment were initially frustrated because they wanted the immediate relief of pain and stress that comes when the child is removed from the home.

As tempting as it is to have the pain and stress of a troubled child lessened by removing the child from the home, eventually, that child will return home and their prior problems can return with them.


Families First solves problems where change is real and long-lasting -- at home with a family. Families First strengthens families. Everyone learns skills, even non-referred children. Mom and dad learn to parent together. Troubled children feel less desperate and more responsible.

Children change and families are healed. Families First is the most humane and effective method for changing troubled children that we have experienced. It should be the first step, and it will probably be the last, in a family's journey of healing.

Referring a child to residential treatment temporarily transfers the burdens of parenting to professional staff with the hope that change will occur. It's like giving a person a fish when the person is hungry.

Families First partners with the parents in creating change. It is like teaching a person to fish to satisfy their hunger. It is more effective and more fully consistent with welfare principles.
